III. CONSIGNMENT / SHIPMENT CERTIFICATE FOR SAUDI ARABIA

1	Halal facility registration certification through SFDA Portal	3750 SAR + VAT (Per Year)
2	Halal Shipment / Consignment certificate through SFDA Portal	1000 SAR + VAT (Per Shipment / Consignment upto 27 MT)
3	Halal Centre Logo through SFDA Portal	6000 SAR + VAT (Per Year)
4	For the above each process – administrative fees	INR 1,000

Note:

- A. For Halal Facility registration through the SFDA, the client must be certified under the GSO Standard by Halal India.
- B. The shipment/consignment certificate will only be issued after the Halal Facility registration is complete.
- C. If a shipment/consignment exceeds 27 MT, the charges will double per 27 MT. For example, if the shipment/consignment is 75 MT, the charges will be tripled (27×3), and this sequence will be followed accordingly.
